Freedom Holding Corp. is a public company incorporated under the laws of the state of Nevada, USA. The holding carries out financial activities, retail brokerage operations, advising on investment, securities trading, investment banking, underwriting, banking and insurance services through its subsidiaries in Kazakhstan, USA, Ukraine, Uzbekistan, Kyrgyzstan, Armenia, Azerbaijan, UAE, Germany, UK, Turkey and Cyprus, and also has representative offices in Greece, France and Spain. The holding reports to the US Securities and Exchange Commission (SEC). The shares are listed on the Nasdaq Capital Market, and they are also included in the official list of the Kazakhstan Stock Exchange (KASE). Holding's subsidiary, Freedom Finance Europe Ltd., is a direct member of Euroclear and EuroCCP.

In turn, Freedom Capital Markets the American subsidiary of the Holding operates on the NYSE floor and is a qualified brokerage firm - NYSE Blue Line. It has a license from FINRA to carry out activities in the capital markets, as well as to work in the field of investment banking.

At the third quarter-end of fiscal 2023, the revenue of the Holding was \$214.5 million; net profit was \$62.9 million; and assets were \$5.368 billion.

The number of the Holding's customers exceeds 2.2 million people.

It is worth noting that since the listing (October 15, 2019) on the NASDAQ stock exchange, the share price of Freedom Holding Corp. (ticker FRHC) rose by more than 466%. The maximum price reached \$81.6 per share. The maximum sales volume of FRHC shares was 3.7 million pcs.

As of today, the holding's major institutional investors include BlackRock Inc, Vanguard Group Inc, Geode Capital Management LLC, HSBC Holdings PLC, Swiss National Bank and others.

The holding's subsidiary brokerage company is Freedom Finance Global PLC, a broker with new opportunities specializing in servicing retail investors. The company is registered with the AIFC, has a license from AFSA and operates with elements of English law. Freedom Finance Global customers have direct access to stock exchange operations on international financial markets (NYSE/NASDAQ, London Stock Exchange, HKEX, Frankfurt Stock Exchange), KASE and AIX, as well as to the holding's most popular and highly-demanded service - participation in initial public offerings (IPOs).

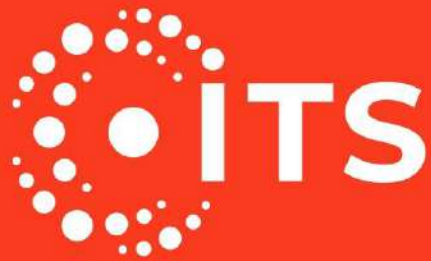

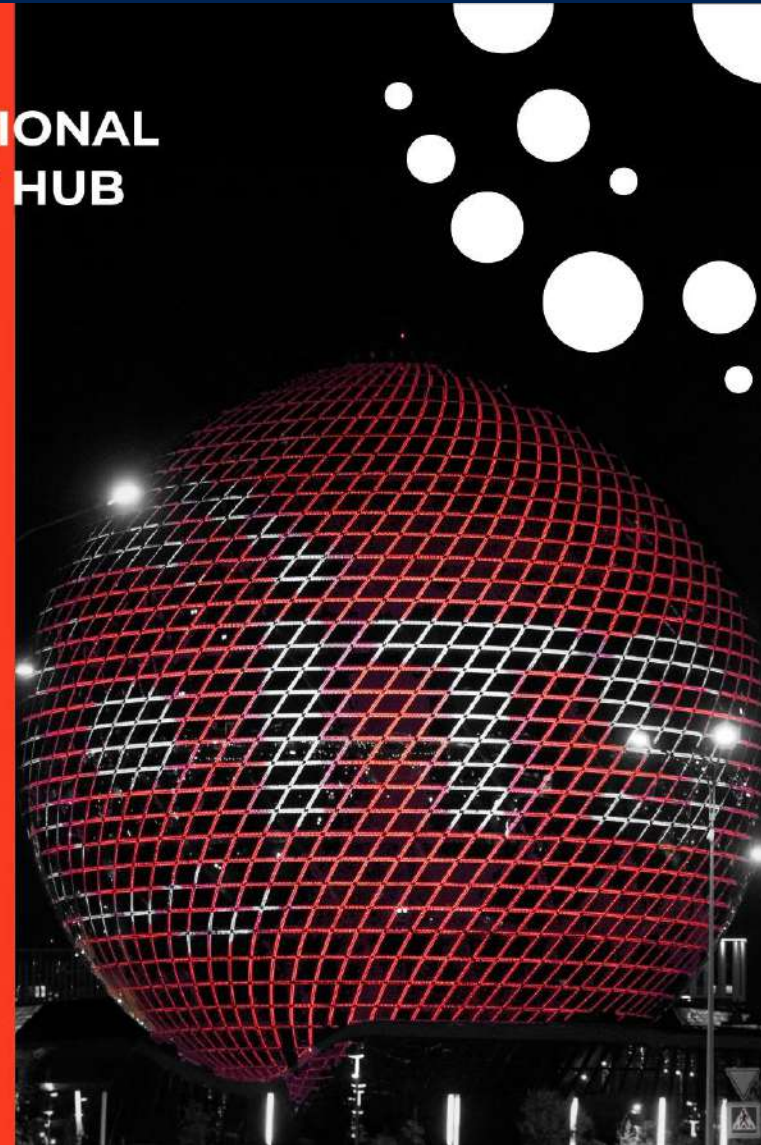


